### The following Revenue related items are included in the Proposed FY 22/23 Budget:

- The property tax rate will remain at .22 per \$100 of real property for FY 22/23.
- The rate to apportion to the Richfield-Misenheimer Fire Department for fire and rescue will remain at .07 of the total .22 property tax rate proposed for FY 22/23.
- The Village is eligible to receive NCDOT Powell Bill funds during FY 22/23 as the .15 mile of Colony Apartment Road was acquired by the Village from NCDOT's maintenance responsibilities during FY 11/12.
- Pfeiffer University signed a 5-year police services contract on July 8, 2019 with the base contract starting at \$240,000 increasing 3% each fiscal year. This year the revenue is expected to be \$262,254.
- A \$50,000 payment from EDP Renewables is expected as payment in lieu of installing a hardscape as part of the negotiated solar farm agreement.
- The second tranche of restricted revenue from the American Rescue Plan in the amount of \$120,467 is expected.

#### The following Personnel related items are included in the Proposed FY 22/23 Budget:

- Pay increases are budgeted for FY 22/23 with the primary focus of bringing police salaries in alignment with peer communities. There will be a 5% increase for all positions. These increases were implemented to attract and retain qualified personnel during a time of police officer shortages and to align with peer communities.
- The 401(k) plan employer contribution will remain at 5% for employees eligible to participate in the 401(k) plan.
- Health, Dental, Life, & Accidental Death & Dismemberment (AD&D) insurance renews December 1, 2022. The FY 22/23 Budget assumes an 18% increase in health insurance premiums, an 8% increase in dental insurance, and a 10% increase on Life/AD&D premiums upon renewal on December 1, 2022.

■ The NC Local Government Employee Retirement System (LGERS) employer contributions will increase for FY 22/23 (LOCG=12.28% which includes a death benefit of .18% up from 11.56% which included a .21 death benefit and LOCL-Local LEO=13.04% which includes a .14% death benefit up from 12.10% which included a .14% death benefit).
